### Leaving the Leaf Season

The Village is continuing leaf pick up through the first week of December. After the first week in December you will need to bag your leaves and put out for trash pick up. So, as much as you can, please rake your leaves now and have them at the curb.

### Fire Hydrants to be flushed...



Our crews plan to flush the village's fire hydrants **on December 8<sup>th</sup>**.

This process stirs up sediments in the water lines which can cause temporary discoloration of the water.

Residents may notice a brownish tint to their water after the hydrants in their neighborhood have been flushed. If so, run the water through a faucet for a few minutes and it should clear up.

Also, residents should avoid doing laundry while hydrant flushing is underway, and may also want to run their washing machine through a rinse cycle before doing laundry.

## 21-year project completed!

The Village of Bremen is now in compliance with the U.S. Environmental Protection Agency's nationwide mandate for municipal storm sewers to be separated from sanitary sewers.

It was twenty-one years ago that village employees Byron Bowersox and Ed Hammond started the process of separating the storm and sanitary systems.

Because they undertook this work in addition to their usual daily responsibilities of operating the village's water and wastewater plants, the pipeline separations were done incrementally with certain segments being completed each year.

Over the 21-year project, Byron and Ed have laid about 22,000 feet of storm sewer pipe along with installing several new catch basins.

Thanks to their ability to design and build most of the system without having to hire consultants and contractors, it is estimated Byron and Ed saved the Village nearly \$3 million!
