- Credit card payment 90day trial period is being tested for the Village
  Residents to have an option to pay water bill through a credit card so they

  There is a rental option with a buyout of equipment for approx. \$280.00
  and a fee of approx. \$30.00 annually
  Eventually we can look at paying online depending on the success of the
  credit card trial.
