Jeff:

Worthington property at south end of village that is for sale. This could possibly be bought and used as farmland. If so, this would have to be changed in zoning ordinance and permitted use.

Sue:

Questions asked at the previous Council meeting was brought to the Committee -

Demolition Permit:

An inspector needs to check properties, correct size, during construction, including safety issues. John will check in accordance with building permits that have been submitted. If safety issues, etc. There should be a project inspector working for the Village to insure many of these items are correct. If this should happen, the Village would have to hire a person of this knowledge. If that happens, the cost of a building permit would increase to around \$500.00 or more instead of the \$100.00.

Check demolition sites and when a demolition permit is needed. The Committee agreed that anything over the size of $8' \times 10'$ needs to have a demotion permit. Small sheds, especially metal ones , under $8' \times 10'$ may be removed without this permit. Because the spread of dust, asbestos, lead paint, debris or any other foreign product, this is required. The Committee will look at Lancaster's demolition permit and come back in August with their suggestions to revise one for Bremen.

Mike:

To reward residents for remodeling their homes, keeping their properties clean, perhaps an award could be given for these individuals. We will think this over and come back with suggestions.

The Fairfield County Board of Health will be called on 151 Purvis Avenue and 221 Purvis Avenue for open cleanouts for their sanitary sewer. Mike will call Board of Health tomorrow (July 3) and require immediate action.
