Record of Proceedings Village of Bremen Council Meeting September 12, 2016

The Council of the Village of Bremen was called to order in regular session by Mayor Tad Moyer at 7:00 P.M. The council, residents and visitors stood and recited the Pledge of Allegiance. Roll call was taken. Members present were Troy Tripp, Toni Harper, Debbie Wolfe, Dave Ray, Sherman Prince and Mike Henwood. The Village Administrator, Jeff White was also in attendance; Clerk-Treasurer Kelley Tripp was absent.

Motion by Wolfe to approve the minutes from the August 11, 2016 regular Council Meeting as written. Second Tripp.

Guests and Residents:

Mary Hoffman (Resident) Gave a brief summary of her investigation into the alley at issue with the Township. She gave Council a copy of her timeline with minutes from various meetings. Discussion then ensued regarding recycling.

Mayor's Report: (Council Pres Mike Henwood)

Sheriff's Report: (Deputy Busby)

Deputy Busby was absent but had previously distributed his monthly report to Council. There was discussion regarding Ordinance against barking dogs in the Village. Mayor and Harper suggested that we amend the Ordinance; the Ohio Basic Code is unenforceable.

Clerk/Treasurer's Report: (Jennifer Storey Asst. for Kelley Tripp)

The Clerk submitted a report to Council. Highlights of the report are as follows:

- Our current checking balance as of August 31, 2016 is \$495,860.75
 - July 31, 2016 was \$507,302.12

- Our fund balance as of September 11, 2016: (read report to council).
- We have spent 52.75 percent of our permanent appropriation budget for 2016.
- We have received 67.99 percent of our annual revenue budget for 2016.
- The Magic Number is 67.73%

Discussion ensued whether or not there should be a record of the no-quorum non-meeting. The record was read. Henwood moved to accept the record; Harper second. Tripp, yea; Harper, yea; Wolfe, yea; Ray, yea; Prince, yea; Henwood, yea. Motion passed.

Dan Rutherford (Resident) There was some confusion as to where he should go to be put on the agenda, therefore the Mayor allowed him to speak for the record regarding the pond in Howell Park. He gave an overview of his work and commented on the safety issues urrounding the pond. It was decided to have an electrician give us an estimate to get the pond appropriately wired.

Tracy Shahan (Resident) Read a letter and gave a donation to the park for the fence totaling \$150. She praised how beautiful the park looks.

Administrator's Report:

The Village Administrator submitted his report to Council. His report included the following items he has worked on since the last council meeting:

- Attended meetings of the Villages standing committees and represented the Village at the Fairfield County Regional Planning Commission;
- Produced and issued the newsletter, The Village Voice, for the public;
- Updated the status of the Water Well project; would like to decide on a contractor at the September meeting;
- The Village will participate in Community Care Day in September;
- Put out bids for paving;
- The contract between Bremen and Rushville for Utility Billing expires this year and

Mike and Jeff are scheduled to attend Rushville's Council meeting on 9-14-16. The Mayor questioned the need for the Village to even have this Well installed, as our system is good enough to handle the chemicals if the plume does make it down here. Henwood and Ray think that we should have this well to have a back-up, and to compensate for any future growth of the Village. Any firm decision on the water well will be made next month when we receive the estimate.

There was discussion about reports of brown/orange water in various places in the Village; there was also extensive discussion regarding raising water rates. Mike Henwood nanded out a breakdown of potential rate changes for perusal.

The Pay Authorization was read in its entirety; with some explanations interjected where appropriate.
