ITEM 1: Variance . Classification change from mixed use commercial to residential for property located at 164 Walnut Street. Parcel # 0350141100.

Fiscal Officer stated that to correct an issue with a OWDA loan disbursement(s) issued for the WWTP that we need to move the funds from pooled funds in 5201 (wastewater treatment plant) and transfer to fund 9901-923-0000 (OWDA loan receipts) Further we will need to increase appropriations to make final payment to CT Engineering. The amount of the transaction will be \$112,000.00. This will be completed when County Auditor's office acknowledges the transfer and appropriation.

Motion to transfer funds from 5201 Wastewater Treatment funds OWDA loan proceeds in the amount of \$112,000.00 to fund 9901-923-0000, OWDA loan receipts.

Discussion: Fiscal Officer advised the appropriation change will be addressed at the July 13th council meeting.


