Pool chair update – A. Taylor found electric pool chair for \$2,900.00. Discussion on purchasing it this year. L. Coakley and A. Taylor will review the budget and see if this is possible. S. Grimm said she would pay up to \$1,200.00 towards purchasing the chair.

Water Plant brine tank lid update – lid is on and the EPA had done away with the violation.

Hull Engineering update -A. Taylor spoke with Alan today. Plans are signed and sent them back to Alan. Hoping for a start date in September due to the cost of supplies. We will start bidding then.

We will start bidding for resurfacing Marietta Street in August 2021.

Northridge lift station revamp update – Jimmy Downard is working on the lift station. There are more houses tapped in which made the lift station struggle. The lift station was installed 20 years ago to take care of 2 houses. If Northridge continues to be developed, the current lift station will not be able to sustain its own. Water Operator F. Fondale will be rebuilding both pumps.
