
**Solid Waste Ordinance 1-2-18** The Finance Committee has reviewed the 1 year extension of the Shackelford contract and determined Ordinance 1-2-18 increasing resident fees 12% above the contract rate can be reduced to 3.5% to cover expenses. Finance is recommending that Council repeal Ordinance 1-2-18 and increase rates effective 2-1-2021 by 3.5%. **Motion:** T. Tripp: Second: T. Wesaw: repeal Ordiance 1-2-18 for the January 2021 meeting and present a resolution for approval for a one year of 3.5% increase. **Roll Call:** T. Wesaw yea, T. Harper yea, D. Wolfe yea, T.
