Craig Dennis – 230 Bartlett Street drainage issues. 2 inches of rain we received last week. Fourth time in the past few years that he's had water clear around his house. Halfway down the street has water. Few inches from coming into the garage. Catch basins needs to be cleaned out. He feels it needs cleaned from Bartlett to Spring down to Marietta Street. He suggests using Fee Corp to clean from Bartlett and Spring Street. He stated that Fee Corp took 27 tons of gravel out a prior time and used the camera. C. Dennis feels we should vac Spring Street all the way down to Marietta Street because it's never been cleaned out sinse he has lived here. Not sure why the line is laying half full of water. Would like to see us at least get a quote.

Jason Nicolia – Is concerned with 224 Bartlett Street drainage issues. Street flooding started in 2018 for him. The town put money into cleaning drains but they are backed up again. The sewer at the end of Maple and Bartlett is holding water. Started when they fixed the drains by the old junk yard. He would like to see a larger pipe put in so that water doesn't fill up in his yard. Pipe only measurers 16 inches. His concern is that kids are playing in the sanitary water. Would like to see the access points be paved in order to now allow water to go in. He said there is sediment in the line. He would like to see more maintenance done on the drains. Safety and Infrastructure will review the situation and study from CT Consulting.

T. Harper suggests taking this to Safety and Infrastructure. Have Craig Dennis and Jason Nicolia come to the committee meeting October 20,2021 at 6pm. They will review at the committee meeting.
