50 people or less shall require two lifeguards More than 50 people shall require three lifeguards All parties attending are counted whether they swim or not. No parties greater than 150 people.

Those wishing to cancel their party must do so within 3 days of their scheduled date in order to qualify for a refund. Cancelations by the Village of Bremen due to inclement weather or other unforeseen circumstances shall be fully refunded.
