THE MAYOR SAID WE WILL HAVE SUMMER WORKERS TO HELP WITH THE MOWING AND TRIMMING IN THE PARK. WE ALSO WILL HAVE A VOLUNTEER TO HELP WITH THE UPKEEP OF THE FLOWER BEDS.

- 2.BILLY ROBINETTE REPORTED THE VILLAGE WILL PURCHASE TOPSOIL FOR VARIOUS NEEDS IN THE VILLAGE.
- 3.AFTER CONFERRING WITH OUR INSURANCE COMPANY, DEBORAH WOLFE SAID IT HAS BEEN DETERMINED THAT BEEHIVES WILL NOT BE PERMITTED IN THE PARK.

IT WAS REPORTED THAT THE KOI POND HAS HAD TWO LEAKS IN THE LINER. BOTH OF WHICH HAS A TEMPORARY FIX. IT WAS YET TO BE DECIDED IF THE POND LINER CAN LAST ANOTHR YEAR, OR IF THE LINER SHOULD BE REPLACED. IF IT IS REPLACED, MONEY WILL BE WITHDRAWN FROM THE BREMEN ACTIVITIES FUND, WHICH IS PART OF THE FAIRFIELD FOUNDATION.
